1. General description

The 74LVC2G32 provides a 2-input OR gate function.

Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in a mixed 3.3 V and 5 V environment.

This device is fully specified for partial power-down applications using I_{OFF}. The I_{OFF} circuitry disables the output, preventing a damaging backflow current through the device when it is powered down.






5. Functional diagram












Fig 10. Package outline SOT505-2 (TSSOP8)




Fig 11. Package outline SOT765-1 (VSSOP8)




Fig 12. Package outline SOT833-1 (XSON8)




Fig 13. Package outline SOT1089 (XSON8)




Fig 14. Package outline SOT996-2 (XSON8)




Fig 15. Package outline SOT902-2 (XQFN8)




Fig 16. Package outline SOT1116 (XSON8)




Fig 17. Package outline SOT1203 (XSON8)
